

HUNTING CONTRACT of Trophy Chasers Hunting LLC. Please sign and return all pages

1. This agreement entered into by and between Trophy Chasers Hunting LLC and the below endorsed client(s), sets out all aspects of the complete agreement between the parties and reflects the final agreement concerning the services to be performed and goods provided by Trophy Chasers Hunting LLC. as well as respective rights and duties of the parties. The final resolution of all previous discussions and negotiations are set forth below and there are no implied terms to this agreement other than those expressly set forth herein. In no way does this contract or any articles herein guarantee or promise the below undersigned a kill or shooting.

2. Guide/hunter assignment shall take place only after arrival in camp and solely at the discretion of Trophy Chasers Hunting LLC . This is not a contract for personal services for any one specific individual guide. Hunter/guide ratio shall be 2 on 1 unless otherwise mutually arranged between Trophy Chasers LLC and client. It is fully understood and agreed that various hunting methods, strategies and in the field activities may occasionally require temporary separation of guide(s) and client(s). This is not a contract for constant physical side by side accompaniment.

3. The following service and equipment provided by Trophy Chasers Hunting LLC will be tailored by Trophy Chasers Hunting LLC to the nature of the hunt and terrain. a. All meals, dining, sleeping and toilet facilities. b. Game handling: in the field, to camp or processing plant. c. All transportation, if required, in the field is based upon the season and location of the camp. Four wheel drive vehicles, when necessary for transportation in the field, will be driven by Trophy Chasers/guide. d. Transportation to and from nearby designated commercial airports for hunters flying into the area, provided previous written request is made to the Trophy Chasers Hunting LLC. by the undersigned at least 30 days prior to arrival. No transportation will be furnished by Trophy Chasers Hunting LLC. prior to the first day of service listed by Trophy Chasers Hunting LLC.

e. Weather and other hunting conditions may require very basic and primitive facilities. 4. Hunter (s) shall furnish: a. Items of personal comfort.

b. Weapons and ammunition which are legal for the taking of game in the state you are hunting in, Colorado c. Valid Colorado habitat stamp and hunting license for game sought and hunter's safety card and any special permits.

5. Hunter's duties, all hunters shall at all times: a. Conduct themselves in a civil and orderly manner.

Not consume illegal drugs at any time or alcoholic beverages during hunting hours and shall remain mentally alert at all times. d. Observe all hunting and camp rules as presented by Trophy Chasers Hunting LLC, either in writing or verbally. e. Strictly adhere to all Colorado Department of Wildlife regulations and Colorado Statutes pertaining to hunting and safety and accept all responsibility for any violation of such regulation or Statute. f. Pay all meat processing costs. g. The undersigned shall not directly or indirectly compete for any of Trophy Chasers Hunting LLC. hunting leases or solicit hunting rights from any of Trophy Chasers Hunting LLC private land Lessors for three (3) years from the date of the execution of this contract and shall accept all liability for any breach of this provision. 6. The undersigned hunter(s) Understand and Agrees that: a. Hunting activity involves certain inherent risks of loss, injury and illness. Each hunter assumes that risk of loss, injury and illness. Furthermore, each hunter agrees to indemnify and

hold harmless the Trophy Chasers Hunting LLC, its employees, agents, contracted personnel and Trophy Chasers Hunting LLC. Lease Lessors, from any and all liability, costs, claims and demands whatsoever, including costs of any legal action, including reasonable attorney's fees. b. **The final payment must be made in the form of: Cash, Travelers Check or Cashier's Check 30 days prior to arrival in camp. No personal or company checks accepted.** c. Deposits represent reservation of space that is then unavailable to other hunters, and are not refundable. In the event of a cancellation, Hunter(s) shall give Trophy Chasers Hunting LLC 90 days written notice of said cancellation. Hunter(s) shall receive 100% refund of his/her deposit only if Trophy Chasers Hunting LLC. can obtain a replacement Hunter(s) for the specific canceled date. If a replacement Hunter(s) is not obtainable, deposit(s) may be applied to the following year and the current year's hunt prices shall apply. d. There shall be no refund or proration due to inclement weather or for any other reason beyond the control of Trophy Chasers Hunting LLC. that the Hunter(s) should leave the camp before the expiration of his/her hunt. e. If a Hunter(s) is unwilling to abide by all the Trophy Chasers Hunting LLC. rules of the camp either verbally or in writing and abide by the terms and conditions of this contract, at the sole discretion of Trophy Chasers Hunting LLC. the Hunter(s) shall be asked to leave the camp and the hunt canceled with no refund. Trophy Chasers Hunting LLC. relies that you are a Hunter(s) and have sufficient hunting skills and abilities for the type of hunt booked, along with intimate knowledge of the operation of your weapon, and that you are in good physical condition. All physical limitations or health problems must be made known to Trophy Chasers Hunting LLC. in the Medical and Physical Condition Release. You must also assume all responsibility

for such conditions and hold Trophy Chasers Hunting LLC harmless as described above. g. Hunting procedures and activities by Trophy Chasers Hunting LLC. depend on weather, game conditions, skill and physical conditions of Hunter(s). Trophy Chasers Hunting LLC. may, in its sole discretion, change camp locations, hunting areas and methods to best increase opportunity for success. Past kill success ratios are not guaranteed to be duplicated for current and subsequent years. h. In the event the undersigned is unsuccessful in obtaining a hunting license, Trophy Chasers Hunting LLC. shall provide landowner vouchers when available for an additional cost agreed upon before booking the hunt. If no voucher is available then you may choose to have your deposit applied to the next years hunt or request a refund in writing. Trophy Chasers Hunting LLC. has 60 days to refund any requested deposit. i. The undersigned acknowledges that they are paying for the services of Private hunting Land only leased by Trophy Chasers Hunting LLC. and that the undersigned is not being charged nor has paid for any service on Public Land Hunting Areas. Trophy Chasers Hunting LLC. accepts no responsibility or liability for the actions of the undersigned while hunting outside Trophy Chasers Hunting LLC. private land leases. j. The undersigned authorizes Trophy Chasers Hunting LLC and Trophy Chasers Hunting LLC staff to take photographs of any and all game animals harvested by each undersigned Hunter(s). Furthermore, the undersigned authorizes only Trophy Chasers Hunting LLC. to use said photographs and the likeness of the undersigned Hunter(s) and/or any game animal harvested for promotional purposes. If Hunter has a prior contract in place for such use they allow Trophy Chasers Hunting LLC. limited use of Hunter's likeness and/or harvested game animal for promotional purposes. 7. Each undersigned acknowledges that he/she has read all of

the informational material presented and displayed by Trophy Chasers Hunting LLC pertaining to specific hunt dates, Trophy Chasers Hunting LLC, fees, license fees, accommodations, services provided, location and terrain description of hunt areas, weather considerations, game conditions, and hunting methods and agrees that the content of said material coincides with all information received and represented by telephone by Trophy Chasers Hunting LLC. No guarantee has been either expressed or implied on availability of game animals or weather conditions or any condition(s) out of Trophy Chasers Hunting LLC. control. Where differences exist, this written contract shall control. This agreement shall be binding upon the parties hereto, their heirs, representatives and/or agents. Pursuant to Sec. 12-55-105 (I)(E) and (I)(D) Colorado outfitting activity is regulated by the registrations director of the Department of Regulatory Agencies requiring Trophy Chasers Hunting to be bonded through Merchants Bonding Group and is carried its liability insurance through the Safari Club International/ T.H.E. Insurance Company. Proof of bond and insurance is available upon request. 8. Any lawsuit, judicial proceeding, or any other action concerning this contract or provisions hereof shall be instituted only in the state of Colorado. The Hunter(s) damages are limited to the price paid by the Hunter (s) directly to the Trophy Chasers Hunting LLC. as consideration for this agreement. No claim shall be made for proximate damages of a different amount. Nor may any recovery be had for incidental or

consequential damages. The undersigned shall not engage directly or indirectly in any slanderous, libel or defamatory activity against Trophy Chasers Hunting LLC. neither verbally or in writing and agrees to accept any and all liability for such activity. If any party hereto pursues legal enforcement of this contract the non-prevailing party shall pay the cost and reasonable attorney fees of the prevailing party. By signing below the parties hereunto acknowledge that they understand all the terms of this contract and furthermore agree that this contract shall be governed by the law of the state of Colorado, both as to its interpretation and performance.
